Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The start date for the above Order is 07 June 2011

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **Nottingham City Council**, **Loxley House**, **Station Street**, **Nottingham NG2 3NG** on **Tuesday 8 November 2011** at 10.00am.

The effect of the Order, if confirmed without modifications, will be to stop up footpath no. 28 commencing at a point on Station Street at (A) SK 5754 3925 and proceeding in a westerly direction and ascending the steps and across the footbridge crossing Nottingham Midland Station then descending the steps onto the station platform then continue south for a distance of 4 metres then west for a distance of 16 metres to the steps adjacent to the eastern boundary of the compound and western boundary of the car park then continue south to Queens Road at point (B) SK 5751 3912 having a length of 160 metres and a width varying between 1.8 and 3.5 metres as shown by the solid black shading on the Order Map; and

Improve the alternative route along parts of the footways on Queens Road, Carrington Street and Station Street as shown by the dashed black line between points (A) and (B) on the Order Map by resurfacing where required, to be used as a replacement for footpath no. 28 having a length of 337 metres and a width varying between 2.0 and 5.5 metres.

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents) to everyone who has made an objection or representation and the applicant and any other person who has made a representation.

Within 14 weeks of the start date [13 September 2011]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies to the Authority, the applicant, every other person who has made an objection or representation and any other person who has made a representation (excluding copies of any supporting documents).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy to the Authority, everyone who has made an objection or representation and any other person who has made a representation (excluding copies of any supporting documents).

4 weeks before the date of the inquiry [11 October 2011]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority and the applicant (excluding copies of any supporting documents although none should be submitted with a proof of evidence).
